4. *Affidavit of delayed registration of birth;(if not reported after 30 days): BD 10.340;*
5. *Five (5) sets of photocopies of first page of parents passport including the pages where their residence visas are stamped;*
6. *Original PSA-Marriage contract of parents (if married in the Philippines) or Authenticated by the Ministry of Foreign Affairs, Bahrain (if married in Bahrain) Provide five (5) copies;*
7. *Personal appearance of minor children;*
8. *Passport Fees: BD 25.000; and*
9. *Report of Birth: BD 10.340*
