Sentro Rizal QuaranTinig: Patimpalak sa Pag-Awit in Celebration of Buwan ng Wika

I. Rationale

Following the migration of cultural activities to online platforms to accommodate the requirements and challenges of the "new normal", the National Commission for Culture and the Arts (NCCA) International Affairs Section – Sentro Rizal (IAS) is now implementing new modalities for cultural engagement with overseas Filipino communities and interested foreign nationals across the globe. Thus, the IAS has come up with an online singing competition dubbed *Sentro Rizal QuaranTinig: Patimpalak sa Pag-Awit.*

II. Description of the Competition

In celebration of *Buwan ng Wika*, Sentro Rizal Filipinas under the auspices of the NCCA presents *QuaranTinig: Patimpalak sa Pag-Awit* – an online singing competition that highlights Original Pilipino Music (OPM) that uses the Filipino language.

The NCCA will partner with Foreign Service Posts with a Sentro Rizal to promote the contest via online platforms. The process of the contest will similarly be done online, from submission of entries to selection and announcement of winners.

III. Objectives

The competition aims to:

- 1. Introduce a platform for all Filipinos overseas to showcase their musical talent and appreciation for original Filipino music and the Filipino language.
- 2. Promote Original Pilipino Music (OPM) and the Filipino language through online platforms both locally and internationally.
- 3. Encourage overseas Filipinos and interested foreign nationals to celebrate Buwan ng Wika by participating in the music competition.
- 4. Help fulfill the mandate of the NCCA to promote Filipino arts and culture worldwide, through its Sentro Rizal Program.

- * Each SR site has to create its own e-dropbox or identify an email address for receiving entries to be announced to own constituents (no. 9 of Mechanics to be revised by FSP to indicate the email address/drop box prior to dissemination of information)
- * Submission of entries from Sentro Rizal Sites/FSPs to NCCA is on 24 August 2020 (PHST)

Sentro Rizal QuaranTinig: Patimpalak sa Pag-Awit in Celebration of Buwan ng Wika

In celebration of *Buwan ng Wika*, Sentro Rizal Filipinas presents *QuaranTinig: Patimpalak sa Pag-Awit* – an online singing competition that highlights the Filipino language through Original Pilipino Music (OPM).

The National Commission for Culture and the Arts (NCCA) calls on the participation of <u>Philippine Foreign Service Posts (FSP) with a Sentro Rizal</u> and promote the contest via online platforms. The process of the contest will similarly be done online, from submission of entries to selection and announcement of winners.

General Guidelines:

- 1. The competition is free and open to all members of Filipino communities overseas, Filipino migrants and their children, and interested foreign nationals under the jurisdiction of Philippine Foreign Service Posts (FSP) with a Sentro Rizal.
- 2. Participants must sing and record on video a performance of any Original Pilipino Music (OPM) sung in the Filipino language.
- 3. Participants can perform solo, duet, or assemble as a group, with minus one or live music accompaniment.
- 4. Participants are advised to wear appropriate Filipino attire.
- 5. The entire performance should last for at least two (2) to five (5) minutes, including introduction, if any.
- 6. The video must be of HD resolution in 1080p (1920x1080) or higher, in landscape MP4 format. Record in full screen <u>4:3</u> or widescreen <u>16:9</u> aspect ratio.
- 7. Strictly only one entry per participant will be accepted.
- 8. Participants who fail to follow the given requirements will be disgualified.
- 9. Entries shall be submitted to the participants' respective Sentros Rizal, which will in turn create a designated email address to serve as a drop box of entries. The link to the consolidated folder of entries uploaded via google drive shall be officially transmitted by the FSPs to the NCCA.
- Where applicable, the NCCA will seek permission from composers/copyright owners of winning entries to be used for public postings and promotions relevant to the activity.

Submission of Entries:

- 1. Each entry must be submitted with an accomplished **Registration Form** and sent to a designated email address to be identified by the participating FSP with a Sentro Rizal. Only entries duly received and officially endorsed by FSP/Sentro Rizal to the NCCA will be accepted.
- 2. Email content must be in the following format:

- 3. Participants must include in their submission a signed **Video Consent Release Form** to grant the NCCA permission to use their image (in video or photo form), audio, and performance in any online or print platform relevant to Sentro Rizal promotions and programs. It is understood that all materials relevant to the competition will not be used for commercial purposes.
- 4. Deadline of submission to your respective Sentro Rizal is on 20 August 2020 (local time)

Criteria for Judging

Selected members of the NCCA National Committee on Music will be part of the panel of judges. The decision of the judges will be final and non-appealable. Below are the criteria for judging:

Voice Vocal Quality and Technique – tone quality, breath support, intonation, diction and articulation Rhythm and Tempo – voice in relation to music accompaniment, timing	50%
EXPRESSION Performance – how well the meaning/message and mood of the song is interpreted or conveyed	30%
SHOWMANSHIP • Show Design – music selection, effective use of performance

Five Competition Winners

Each will receive an official **Winner's Certificate** and a cash prize (subject to Philippine taxes and auditing regulations) as follows:

First prize: Fifty Thousand Pesos (PHP 50,000.00)
Second prize: Thirty Thousand Pesos (PHP 30,000.00)
Third prize: Twenty Thousand Pesos (PHP 20,000.00)

2 Consolation prizes: Ten Thousand Pesos (PHP 10,000) each

Winning entries will be posted on the social media accounts of Sentro Rizal and will be used in print and video materials relevant to the NCCA's programs.
