## First SPLE in Bahrain A Success

The Philippine Embassy and POLO-OWWA in Bahrain successfully conducted the first Special Professional Licensure Examination (SPLE) on August 24-26, 2018 at the Philippine School Bahrain (PSB) in A'Ali, Kingdom of Bahrain.

A total of twenty-seven (27) room watchers/ proctors and seven (7) support personnel mostly composed of Philippine Embassy and POLO-OWWA staff and PSB teachers were involved in managing the conduct of the three-day SPLE which regularly started at 8:00 AM and ended at 6:00 PM. of the Kingdom of Bahrain plans to institute stricter regulations for those without the appropriate professional licenses and credentials.
